SSL offers dozens of free and low-cost programs and services for residents. We have top-rated youth sports leagues and camps. Recreation also puts on 12 annual events designed to bring families and community together. The Daddy-Daughter Dance in February and the Senior Ball this month are two highlights – the costumes, sets, music, food, and games are first-rate productions. Many other programs are offered in community centers through our partners – ranging from the Columbus Senior Center to the Utah Refugee Training and Education Center, to the Head Start preschool, and of course Promise SSL afterschool and summer activities. All of these have been strategically located in our City with one common denominator – Investing in People.

With the theme *Invest in People* running through so much of the work we do, we regularly take stock of who we are and what services are needed. Most of our programs receive some form of local, state or federal funding or other grants. All of our funders want to know how many people are participating and who they are – young or old, high or low income, American-born or new citizens, and so on. We rely on this data both to design programs that are the right fit, and also to attract the funding to make them possible.

So where do we go to find this information? The US Census. The Census is a fundamental part of our country's founding. In fact, it was set up by our Constitution, and endures today because it defines who we are as a nation, as a state, and even as a small City. The Census is happening this spring – Census survey information will arrive in your mailbox mid-March. The survey asks questions that help us understand our community and predict needs, such as classrooms, jobs, housing and elder care. Without this, we wouldn't really know how to *Invest in People*. We need to **know you to serve you**. It is just that simple.

We need to make sure every single person is counted so we get an accurate representation. This information is used for


You Matter, Be Counted – 2020 Census

City Council Corner


Recently, Utah House Bill 411 (Community Renewable Energy Act) provided cities a pathway toward using 100% renewable energy by 2030. Everyone on the Council was excited to move forward. But after a more detailed presentation from Rocky Mountain Power and Salt Lake City's Sustainability Department, we unanimously agreed not to pass a resolution at this time for several reasons.

SSL is starting a few steps behind other communities. Many of the participating cities already had energy plans in place and have residents who opt in to current Rocky Mountain Power programs like Blue Star and solar energy. At this time, SSL has no sustainability plan and only about 1% of our residents participate in current energy-wise programs.

There are just too many unknowns at this point. HB411 makes no promises about the price of renewable energy – it could be cheaper, or it might be more expensive – only time will tell. But the commitment needs to be made up front. Some suggested passing a resolution, then withdrawing if needed. Because rates will be determined based on how many cities pass a resolution of support, not following through on our commitment wouldn't be fair to others who are participating.

Additionally, HB411 is an opt-out program, meaning all SSL residents would be enrolled with an undetermined additional cost. Business owners and residents would be required to contact Rocky Mountain Power to let them know if they didn't want to participate. Another concern, penalties might apply if too many

residents opt out or if renters abandon contracts. Because of the high number of rentals in our City, we determined it was best to wait and join this effort when more details become available.

I cannot emphasize enough that our City goal is to become 100% reliant on renewable energy. Our first plan of action will be to create a sustainability plan with the support of Rocky Mountain Power. Part of that plan will include encouraging residents and business owners to individually change this conversation by going to rockymountainpower.net to participate in current energy-wise options. We invite all residents to be a part of this process. Please attend City Council meetings and share feedback with your Council representatives – we value your input.

New Traffic Data Collecting Technology

For years the South Salt Lake Police Department has investigated complaints of speeding vehicles. We reacted in normal fashion by sending officers into the area to make an assessment of the problem and take enforcement action in necessary. Unfortunately, and frustratingly, our officers were often unable to detect any violations or even collect sustaining data that would validate the original complaint. But, thanks to one of our officers who believed there was a better way, we have a new tool to help us!

Officer Taylor of the Traffic Division began a search for a system that could help capture data to study vehicle traffic speeds on fatal traffic accident investigations. After extensive research, he found the Black Cat II Radar Recorder by Jamar Technologies, Inc. This new technology can collect traffic data which can then be used to identify specific traffic problems on our roadways. There are many advantages to such a system.

Other types of devices historically used, like road tube traffic counters, speed trailers and officer presence, produce less accurate results. Drivers often slow down when they see a tube across the road, a trailer or the presence of an officer. This means that inaccurate data is collected. With the Black Cat II, there is nothing in the roadway, and the box itself looks like any other utility box mounted on an existing utility pole. This allows officers to collect unaltered,



unbiased data providing more accurate information about the actual traffic concern.

With the multiple capabilities of the Black Cat Radar II, departments have been able to track large vehicles on prohibited roadways by capturing a set length of a desired vehicle. More commonly, the Black Cat Radar is used to track the average speed and the highest speeds of vehicles. The data collected indicates the time of day and the number of vehicles in violation and generates an easy-to-read report for officers and complainants to review. This information is then used by our officers to better educate the community and to determine where and when enforcement action is needed.

With this advanced technology, officers are more effectively deployed to areas where enforcement actions are warranted, and can more efficiently analyze the cause of traffic problems to better identify long-term solutions.

The best feature of the Black Cat II Radar, it came at no cost to the City of South Salt Lake. Officer Taylor secured a Highway Safety Grant to obtain two systems, both 100% grant funded.

DEVELOPMENT UPDATES

ROOFERS SUPPLY COMPANY – NEW BUILDING

In 2018, Roofers Supply Company came to Community Development with a vision of a multi-phase redevelopment project of their existing facilities at 3359 South 500 West. Phase 1 included demolishing the building at 3379 South, formally known as Speedy Towing, and constructing a new office/warehouse headquarters. The new building is now complete and open for business. They will begin moving forward with phase 2, which includes the demolition of their current office building located just to the north. Phase 2 and 3 of the redevelopment will include new warehouse and storage buildings for their products, new parking lots, landscaping and curb, gutter and sidewalk along 500 West.

MILLCREEK STATION APARTMENTS

Located at 3196 S. Washington Street this affordable multifamily building is now complete and 100% leased. Millcreek Station has 70-units with a mix of 1, 2, 3 and 4 bedroom units. Fourteen of the units are market rate, the remaining 56 units target households with incomes ranging from 25-50% of the area median income. Millcreek Station is across the street from the 3300 South TRAX station and features a pool, fitness facility, children's playground and public transit passes.



RIVERFRONT NEIGHBORHOOD FINAL PHASE UNDER CONSTRUCTION

The last phase of new single family homes in the Riverfront Neighborhood is now under construction. The new phase includes approximately 80 additional homes. Richmond American Homes will be building approximately half of the development lots. The homes will be a mix of one and two story units, with designs matching themes of the previous phases of development. Home prices are anticipated to range \$300,000 and up.

Columbus Senior Center Spotlight


