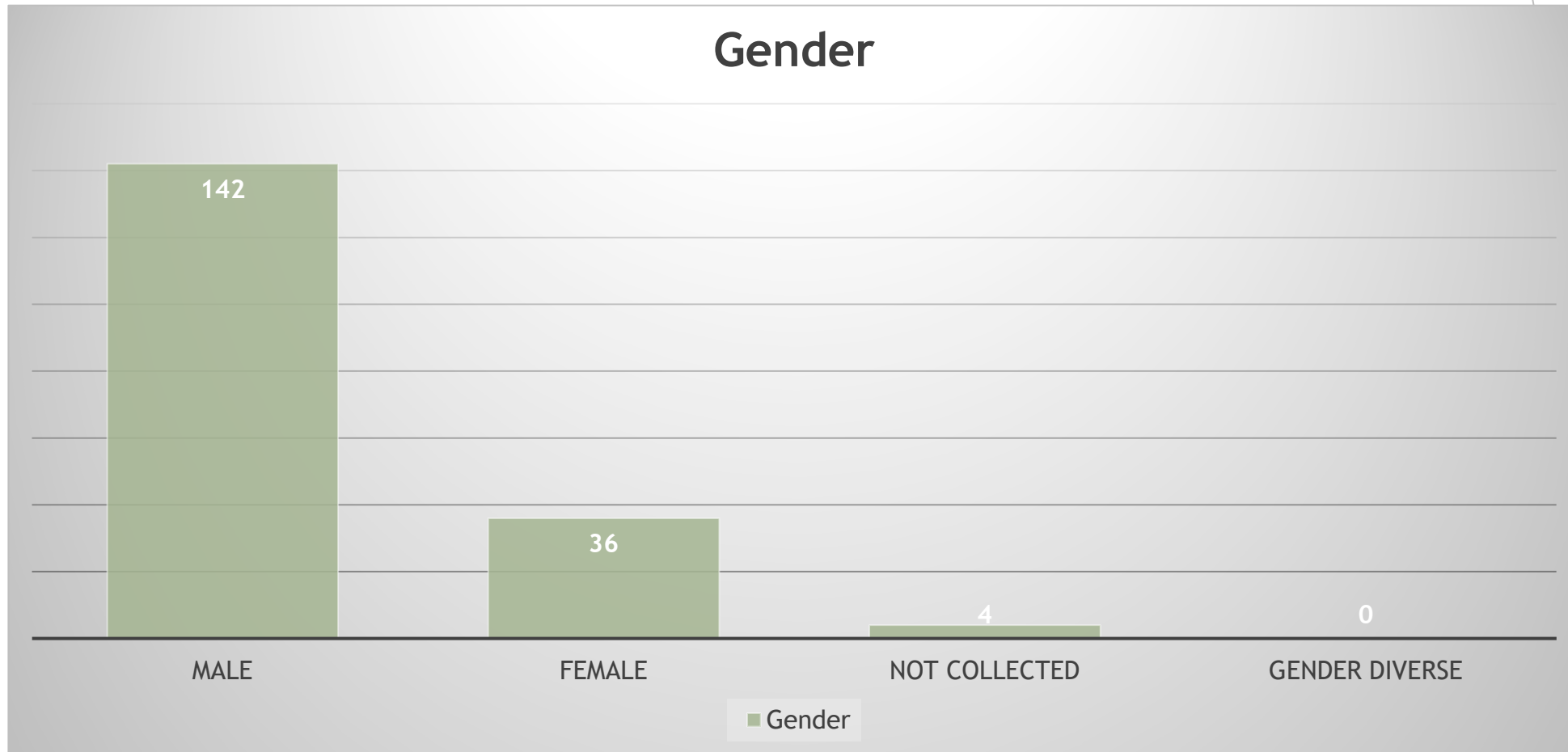
Cases by Race



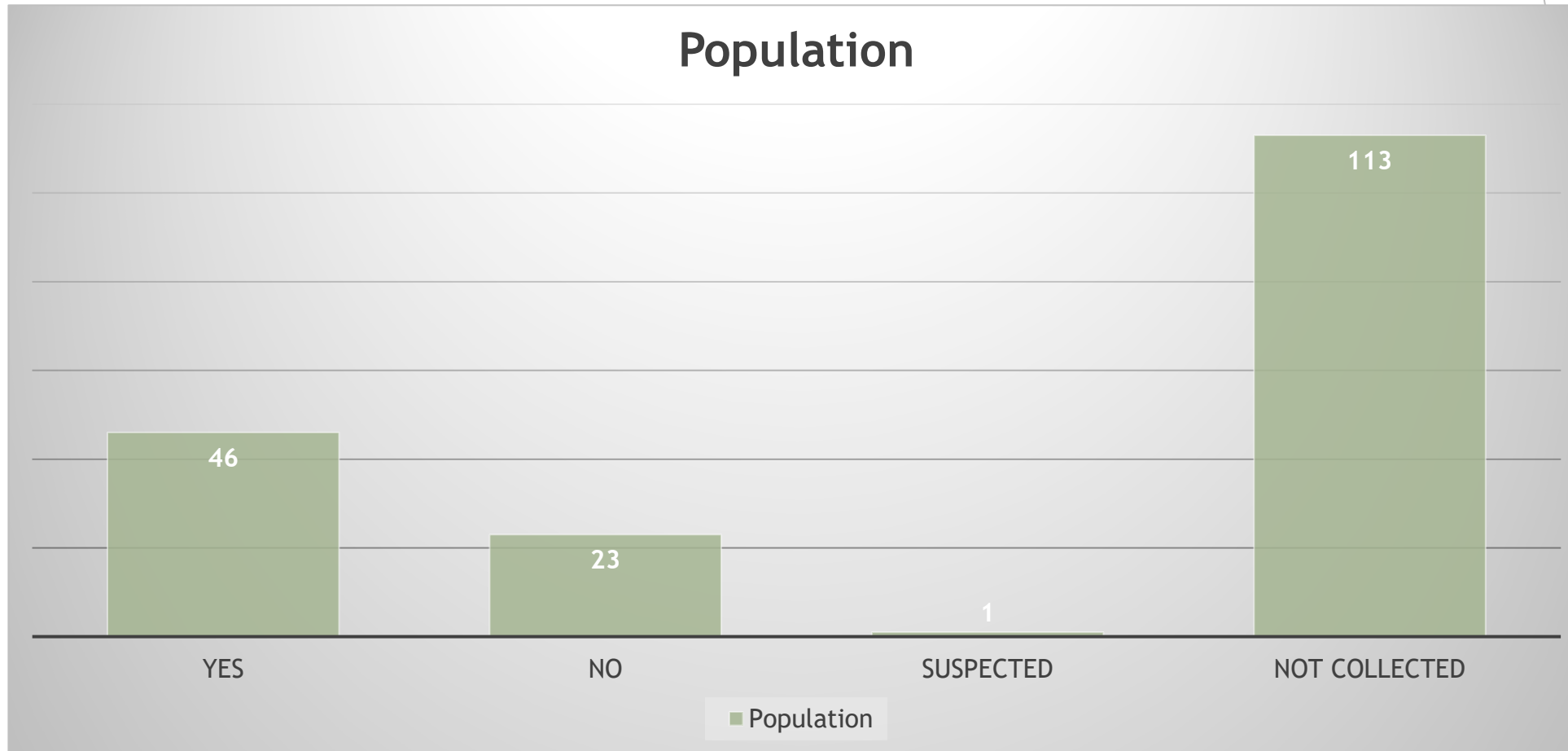
Cases by Age



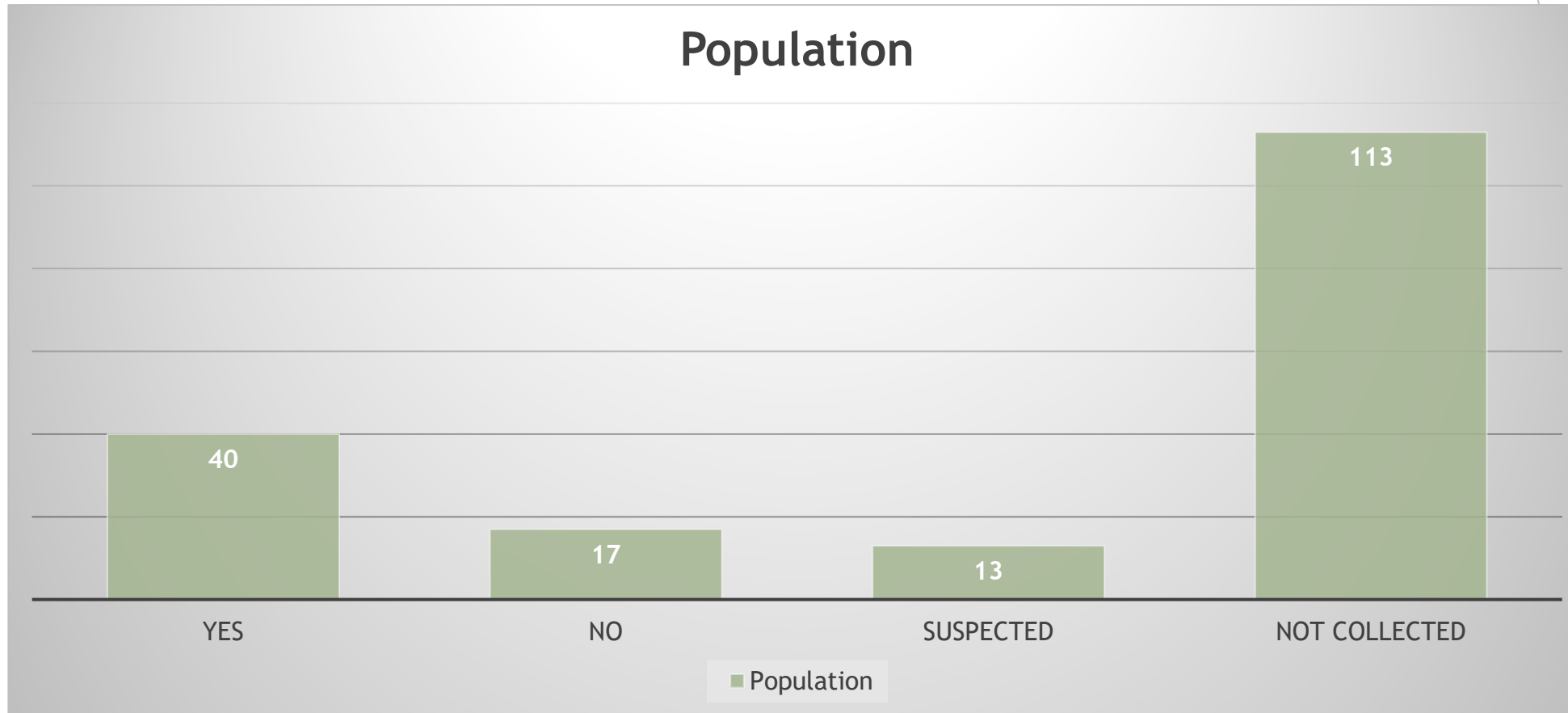
Cases By Gender
